# 1. INFORMATION AND SCOPE OF INSPECTION

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without the need to move any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right are taken facing the front of the property.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. were not inspected or reported on.

**Description** Skjerstad comprises a detached house, with integral garage,

summer house and garden.

Neighbourhood and The property is situated in a residential area of Kirkwall, location within easy reach of all the usual amenities.

Age The original property is understood to have been completed in December 1996, with the Sitting Boom and garage

in December 1996, with the Sitting Room and garage

extensions completed in late 2015.

Weather The weather was cool and dry, following a period of

changeable weather.



## **Chimney stacks**

There is one block built chimney, which is dry-dashed with a concrete cope and single clay chimney can.

Visually inspected with the use of binoculars where appropriate.

# Roofing including roof space

Pitched timber framed roof structure, with OSB sarking and profiled concrete tiles.

Two dormer windows to the front elevation.

Concrete ridge tiles; leadwork flashings to the valleys and abutments.

Fibreglass insulation to the ceiling joists and around the roof rooms.

The roof over the garage is constructed with attic trusses, so there may be the possibility of forming further accommodation within this area.

Sloping roofs were visually inspected with the aid of binoculars where appropriate.

Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so. Head and shoulders inspection of the roof space only.

### Rainwater fittings

uPVC gutters and down pipes.

Visually inspected with the aid of binoculars where appropriate.

# Main walls

The external walls are constructed of a structural timber frame, with blockwork outer leaf.

Walls are dry-dashed externally, with smooth cement render below DPC level and to the ingoes; concrete window cills.

Brick effect quoins to the external corners.

Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.

# Windows, external doors and joinery

uPVC double windows and external doors.

Flush plywood door between the house and garage.

uPVC fascias and soffits.

Internal and external doors were opened and closed where keys were available.

Random windows were opened and closed where possible.

Doors and windows were not forced open.



**External decorations** 

There are no external decorations.

Visually inspected.

Conservatories / porches

There are no conservatories or porches.

Visually inspected.

Communal areas

There are no communal areas.

Circulation areas visually inspected.

Garages and permanent outbuildings

There is an integral garage to the south-east end of the house, with storage area above.

Concrete floor, OSB linings to the walls, plasterboard ceiling (undecorated).

Automatic sectional garage door; uPVC to the rear elevation.

Note: the storage area is formed with attic trusses, so may be suitable for development.

Approximate internal dimensions of the garage: 7.3m x 4.2m.

Timber Summer House to the back garden, with a fitted bar and solid fuel stove.

Internal dimensions 4.9m x 3.9m.

Shelter to the hot tub to the rear of the garage: paving slab floor, timber framed walls and roof, with metal cladding and polycarbonate roof lights.

Internal dimensions 3.8m x 2.5m.

Aluminium framed greenhouse to the back garden. Approximate dimensions 3m x 2m.

Timber garden shed to the front garden.

Timber boarded walls with metal sheeting to the roof.

Visually inspected.



# Outside areas and boundaries

Gravelled parking area to the front of the house; concrete ramp and steps up to the front door, with timber balustrade.

Paving slab paths around the house.

Stone walls to the boundaries.

Two areas of timber decking to the back garden.

Areas of grass to front and rear.

Visually inspected.

# Ceilings

The ceilings are lined with plasterboard.

Visually inspected from floor level.

### Internal walls

Interior walls and partitions are timber framed and lined with plasterboard.

Visually inspected from floor level. Using a moisture meter, walls were randomly tested for dampness where considered appropriate.

# Floors including sub floors

Suspended timber ground floor to the original part of the house; concrete ground floor to the Sitting Room extension. Suspended timber first floors.

Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.

# Internal joinery and kitchen fittings

Fitted floor and wall units to the Kitchen/Dining Room and Utility.

Oak moulded skirtings and facings to the Sitting Room and Kitchen/Dining Room; redwood timber finishes elsewhere. Timber stairs with handrails; oak steps from the Sitting Room up to the Kitchen/Dining Room.

4-panelled softwood interior doors; glazed doors to the Kitchen/Dining Room.

Built in wardrobes with louvred doors.

Built-in cupboards were looked into, but no stored items were moved.

Kitchen units were visually inspected excluding appliances.

# Chimney breasts and fireplaces

There is a solid fuel stove in a recess in the Sitting Room, sitting on a flagstone hearth with a timber mantle.

Visually inspected. No testing of the flues or fittings was carried out.



### Internal decorations

Internal walls and ceilings are emulsioned.

Interior woodwork is varnished.

Tiled splashbacks to the Kitchen/Dining Room; wall panelling to the Bathroom and Shower Rooms.

Floor finishes include oak flooring to the Sitting Room, Kitchen/Dining Room and Hall, carpet to the Bedrooms,

floor tiles to the Utility, vinyl to the Bathroom and Shower

Rooms.

Visually inspected.

**Cellars** 

There are no cellars.

Visually inspected where there was safe and purpose-built access.

# **Electricity**

The property is served by a mains electricity supply to a distribution board and dual tariff meters.

Extractor hood to the Kitchen/Dining Room; extractor fans to the Bathroom and Shower Rooms.

Electric induction hob and double electric oven to the Kitchen/Dining Room.

Hot tub in a shelter building to the back garden.

Switches and sockets are a mixture of chrome and white plastic.

Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

Gas

There is no mains gas in Orkney.

No Calor Gas installation at the property.

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.



# Water, plumbing and bathroom fittings

There is a mains water supply to the property.

The pipework, where visible, is of copper and uPVC construction.

Sanitary ware includes:

Kitchen/Dining Room: single bowl composite sink and drainer.

Utility: stainless steel sink.

Bathroom: spa bath, mixer shower in recess with shower tray and door, wash-hand basin, WC.

En-Suite Shower Room 1 (Master Bedroom): mixer shower

with tray and cabinet, wash-hand basin, WC.

En-Suite Shower Room 2: electric shower with tray and

cabinet, wash-hand basin, WC.

Cold water header tank in the loft.

Visual inspection of the accessible pipework, water tanks, cylinders and fittings without removing any insulation.

No tests whatsoever were carried out to the system or appliances.

# Heating and hot water

The house is heated by an external oil boiler in a cabinet to the rear elevation, heating radiators throughout the house. The heating system is controlled by a programmer, with a 'Nest' thermostat to the Hall, and TRV's fitted to the radiators.

The boiler is assumed to provide domestic hot water, with the hot water cylinder in the cupboard outside the Master Bedroom.

There are also solar thermal panels to the rear roof, which also provide domestic hot water.

Multi-fuel stove in the Sitting Room.

Plastic oil tank on a concrete base to the rear elevation.

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected.

No tests whatsoever were carried out to the system or appliances.

## Drainage

Drainage is understood to connect to the mains drainage network.

Drainage covers etc were not lifted. Neither drains nor drainage systems were tested.



# Fire, smoke and burglar alarms

Smoke detectors fitted to the ceilings of the ground floor Hall and first floor Landing.

Visually inspected.

No tests whatsoever were carried out to the system or appliances.

# Any additional limits to inspection:

At the time of our inspection the property was occupied and fully furnished with floors fully covered throughout.

Pitched roof coverings were inspected from ground level; a detailed inspection of condition was not undertaken.

An inspection for Japanese Knotweed or other invasive plant species was not carried out.


There was no access for inspection to the foundations or behind wall linings.

The drainage system was not open to inspection.

High levels of Radon gas have been recorded in areas of Orkney. No tests were carried out to detect the levels of gas in the property.





# The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The rating is given on a scale of 1 to 100. Other than the cost of fuel for electrical appliances and for cooking, a building with a rating of 100 would cost almost nothing to run.

As we all use our homes in different ways, the energy rating is calculated using standard occupancy assumptions which may be different from the way you use it. The rating also uses national weather information to allow comparison between buildings in different parts of Scotland. However, to make information more relevant to your home, local weather data is used to calculate your energy use, CO<sub>2</sub> emissions, running costs and the savings possible from making improvements.

# The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 42 kg CO<sub>2</sub>/m<sup>2</sup>/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. Based on this assessment, heating and lighting this home currently produces approximately 7.0 tonnes of carbon dioxide every year. # About the recommended measures to improve your home's performance rating

# 1 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about floor insulation is available from many sources including www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation. Building regulations generally apply to this work so it is best to check with your local authority building standards department.

## 2 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. ### PART 1 – GENERAL

#### 1.1 THE SURVEYORS

The Seller has engaged the Surveyors to provide the Single Survey Report. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited Energy Company.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Purchaser's lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors require to amend the valuation in consequence of such information, they will issue an amended Report to the Seller. #### PART 2 – DESCRIPTION OF THE REPORT

#### 2.1 THE SERVICE

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by Statute and this is in the format of the accredited Energy Company.

## 2.2 THE INSPECTION

The Inspection is a general surface examination of those parts of the Property which are accessible: in other words, *visible and readily available for examination from ground and floor levels, without risk of causing damage to the Property or injury to the Surveyor.* 

All references to visual inspection refer to an inspection from within the property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the property.

The Inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

Unless identified in the report the Surveyor will assume that no harmful or hazardous materials have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

The Surveyor will not carry out an asbestos inspection, and will not be acting as an asbestos inspector in completing a Single Survey of properties that may fall within the Control of Asbestos in the Workplace Regulations. In the case of flats it will be assumed that there is a duty holder, as defined in the Regulations and that a Register of Asbestos and effective Management Plan is in place, which does not require any expenditure, or pose a significant risk to health. #### 2.3 THE REPORT
