#### 1. INFORMATION AND SCOPE OF INSPECTION

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without the need to move any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right are taken facing the front of the property.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. 

Accommodation	Porch, Hall, Shower-room, Kitchen, Passage, Sitting-room, Bathroom and Bedroom on the Ground Floor; Bedroom on the western Attic Floor; Bedroom on the eastern Attic Floor; Access to the attic rooms is by separate staircases running from the inner entrance hall and also the passage between the Kitchen and the Sitting-room.

Neighbourhood	Forms part of the scattered rural community of the island of Westray.

Weather	Bright Sun.
Chimney stacks	Stone built chimneys, harled externally with cast concrete soakers and heads above both gables and centrally positioned. A further stack built of concrete blocks extends above the gable wall of the extension. All have been harled externally. Each stack has a clay chimneypot. Most pots are capped or sealed.
Roofing including roof space	Pitched roofs over the original and first extension clad in cement fibre slates. The roof of the shower-room extension is flat and clad in fibreglass.
	BV panels are present on the front aspect of the main roof and on the western aspect of the extension roof.
	Accommodation occupies the majority of the original roof void.
	Glass wool within the extension void prevented inspection of the void.
Rainwater fittings	Black plastic gutters and downpipes fitted.
Main walls	Walls of the original dwelling are of random masonry. The extensions are of cavity concrete block. The whole property has rendering on the outer surface.
Windows, external doors and joinery	All double glazed windows in pvc. A timber gutterboard has been fitted. The eaves of the Shower-room roof have been clad with pvc.
External decorations	The walls of the original dwelling have been painted with masonry paint. Gutterboards have been stained.
Conservatories / porches	A flat roofed timber porch has been erected in the internal angle formed by the junction of the original dwelling and the extension. The external surface of the porch has been clad in vertical weatherboarding. The roof is clad with mineralised bitumen felt.  The timber weatherboarding has been painted with external varnish.
Communal areas	The majority of the access road to the dwelling is shared with the neighbouring farm.

Garages and permanent outbuildings	A collection of outbuildings are scattered to the east of the house. They consist of a block built generator shed (2 metres x 3 metres) with a corrugated cement fibre roof, a traditional single byre, to tie 9 cattle, built of stone walls beneath a pitched roof of stone flags, a large, high, barn (11m x 5.5m) built of stone with a pitched roof of corrugated cement fibre sheets and a lean-to (6m x 2.5 m) also of stone walls with a mono-pitched roof of corrugate cement fibre sheets.  2 "Polycrubs" are set apart from the dwelling and various timber goat sheds lie on the western boundary.
Outside areas and boundaries	The house and sheds are surrounded by lawns and "secret" gardens. Much of the area has been planted with willows which provide much needed shelter.
Ceilings	Generally plasterboard sheeting, taped and filled. Occasional ceiling is lined with timber planking.
Internal walls	Stud partitions clad with plasterboard are installed throughout.
Floors including sub-floors	Floors in the original section are believed to be solid concrete with a "floating" timber floor above. The extension has a solid floor.
Internal joinery and kitchen fittings	"Ledge and brace" and pine panel doors are fitted throughout. Pine skirtings and facings are installed.
Chimney breasts and fireplaces	A Montrose style wood-burning stove has been fitted within the original hearth in the sitting room. It stands on a stone slab, and the original stonework above has been exposed.
Internal decoration	All walls and ceilings have been emulsioned. Skirtings and facings have been treated with Danish oil.
Cellars	None present.
Electricity	Mains electricity wired in double insulated cable.  Meter in a cupboard in Passage
Gas	Bottle butane gas plumbed to gas cooker situated in the Kitchen. Bottles are stored against the gable wall of the dwelling.
Water, plumbing and bathroom fittings	Mains supply to a lagged and lidded storage tank situated in the roof void.  Modern sanitaryware installed.

Heating and hot water	A water filled central heating system fired by an air to water heat pump and augmented by solar gain panels fitted to the roof.  This also heats the domestic hot water.
Drainage	Drainage is to a private septic tank
Fire smoke and burglar alarms	Smoke detectors are present throughout.
Any additional limits to inspection	Access to roof voids was limited.  All floor surfaces were hidden by fitted carpets and laminate flooring.

The outbreak of the Novel Coronavirus (COVID-19), declared by the World Health Organisation as a "Global Pandemic" on 11 March 2020, has impacted global financial markets. Travel restrictions have been implemented by many countries. Market activity is being impacted in many sectors. As at the valuation date, I consider that I can attach less weight to previous market evidence for comparison purposes, to inform opinions of value. Indeed, the current response to COVID-19 means that we are faced with an unprecedented set of circumstances on which to base a judgement.

My valuation(s) is / are therefore reported on the basis of 'material valuation uncertainty' as per VPS 3 and VPGA 10 of the RICS Red Book Global. Consequently, less certainty – and a higher degree of caution – should be attached to our valuation than would normally be the case. Given the unknown future impact that COVID-19 might have on the real estate market, we recommend that you keep the valuation of Mayfield under frequent review.

### **Terms and Conditions**

#### PART 1 - GENERAL

#### 1.1 The Surveyor

The Seller has engaged the Surveyor to provide the Single Survey Report. The Seller has also engaged the Surveyor to provide an Energy Report in the format prescribed by the accredited Energy Company.

The Surveyor is authorised to provide a transcript or retype of the generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by Brokers and Lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the generic Mortgage Valuation Report and the Single Survey. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Purchaser's lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyor, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyor during the conveyancing process which materially affects the valuation stated in the Report, the Surveyor reserves the right to reconsider the valuation. Where the Surveyor requires to amend the valuation in consequence of such information, they will issue an amended Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report is transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon Residential Property.<sup>1</sup>

If the Surveyor has had a previous business relationship within the past two years with the Seller or Sellers Agent or relative to the property, they will be obliged to indicate this by ticking the adjacent box.  $\lceil \checkmark \rceil$ 

The Surveyor has a written complaints handling procedure. This is available from the offices of the Surveyors at the address stated.

#### 1.2 The Report

The Surveyor will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

To date, Purchasers have normally obtained their own report from their chosen Surveyor. By contrast, a Single Survey is instructed by the Seller and made available to all potential Purchasers in expectation that the successful Purchaser will have relied upon it. The Report and any expressions or assessments in it are not intended as advice to the Seller or Purchaser or any other person in relation to an asking price or any other sales or marketing decisions.

The Report is based solely on the Property and is not to be relied upon in any manner whatsoever when considering the valuation or condition of any other property.

If certain minor matters are mentioned in the Report it should not be assumed that the Property is free of other minor defects.

Neither the whole nor any part of the Report may be published in any way, reproduced or distributed by any party other than the Seller, prospective purchasers and the Purchaser and their respective professional advisers without the prior written consent of the Surveyor.

#### 1.3 Liability

The Report is prepared with the skill and care reasonably to be expected of a competent residential surveyor who is a member of the Royal Institution of Chartered Surveyors.

The Report is addressed to the Seller and was prepared in the expectation that it (or a complete copy) along with these Terms and Conditions (or a complete copy) would (or, as the case might be, would have been) be disclosed and delivered to

- the Seller:
- any person(s) noting an interest in purchasing the Property from the Seller;
- any person(s) who make(s) (or on whose behalf is made) an offer to purchase the Property, whether or not that offer is accepted by the Seller;
- · the Purchaser; and

• the professional advisers of any of these.

The Surveyor acknowledges that his duty of skill and care in relation to the Report is owed to the Seller and to the Purchaser. The Surveyor accepts no responsibility or liability whatsoever in relation to the Report to persons other than the Seller and the Purchaser. The Seller and Purchaser should be aware that if a Lender seeks to rely on this Report they do so at their own risk. In particular, the Surveyor accepts no responsibility or liability whatsoever to any Lender in relation to the Report. Any such Lender relies upon the Report entirely at their own risk.

#### 1.4 Generic Mortgage Valuation Report

The Surveyor undertakes to the Seller that they will prepare a generic Mortgage Valuation Report, which will be issued along with the Single Survey. It is the responsibility of the Seller to ensure that the generic Mortgage Valuation Report is provided to every potential Purchaser.

#### 1.5 Transcript Mortgage Valuation For Lending Purposes

The Surveyor undertakes that on being asked to do so by a prospective purchaser, or his/her professional advisor or Lender, they will prepare a Transcript Mortgage Valuation Report for Lending Purposes on terms and conditions to be agreed between the Surveyors and Lender and solely for the use of the Lender and upon which the Lender may rely. Which shall be in accordance with the current RICS Valuation Standards (the Red Book) and RICS Rules of Conduct.

#### 1.8 Cancellation

The Seller will be entitled to cancel the inspection by notifying the Surveyor's office at any time before the day of the inspection.

The Surveyor will be entitled not to proceed with the inspection (and will so report promptly to the Seller) if after arriving at the property, the Surveyor concludes that it is of a type of construction of which the surveyor has insufficient specialist knowledge to be able to provide the inspection satisfactorily. #### 1.10 Definitions

- the "Lender" is the party who has provided or intends or proposes to provide financial assistance to the Purchaser towards the purchase of the Property and in whose favour a standard security will be granted over the Property;
- the "Transcript Mortgage Valuation Report for Lending Purposes" means a separate report, prepared by the Surveyor, prepared from information in the Report and the generic Mortgage Valuation Report, but in a style and format required by the Lender. The Transcript Mortgage Valuation Report for Lending Purposes will be prepared with the skill and care reasonably to be expected from a surveyor who is a member of the Royal Institution of Chartered Surveyors and who is competent to survey, value and report on the Property;

All references to visual inspection refer to an inspection from within the property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the property.

The Inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

Unless identified in the report the Surveyor will assume that no harmful or hazardous materials have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

The Surveyor will not carry out an asbestos inspection, and will not be acting as an asbestos inspector in completing a Single Survey of properties that may fall within the Control of Asbestos in the Workplace Regulations. In the case of flats it will be assumed that there is a duty holder, as defined in the Regulations and that a Register of Asbestos and effective Management Plan is in place, which does not require any expenditure, or pose a significant risk to health. No enquiry of the duty holder will be made.

#### 2.3 The Report

- 1. <u>Category 3</u>: Urgent repairs or replacement are needed now. Failure to deal with them may cause problems to other parts of the property or cause a safety hazard. Estimates for repairs or replacement are needed now.
- 2. Category 2: Repairs or replacement requiring future attention, but estimates are still advised.
- 3. Category 1: No immediate action or repair is needed.

**WARNING**: If left unattended, even for a relatively short period, Category 2 repairs can rapidly develop into more serious Category 3 repairs. The existence of Category 2 or Category 3 repairs may have an adverse effect on marketability, value and the sale price ultimately achieved for the property. This is particularly true during slow market conditions when the effect can be considerable.

Parts of the property, which cannot be seen or accessed, will not be reported upon and this will be stated. If the Surveyor suspects that a defect may exist within an unexposed area and which could have a material effect upon the value, he may recommend further investigation by specialist contractors.

#### 2.4 Services

Surveyors are not equipped or qualified to test the services and therefore no comment can be interpreted as implying that the design, installation and function of the services are in accordance/compliance with regulations, safety and efficiency expectations. However, comment is made where there is cause to suspect significant defects or shortcomings with the installations. No tests are made of any services or appliances.
