### 1. INFORMATION AND SCOPE OF INSPECTION

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without the need to move any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right are taken facing the front of the property.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. were not inspected or reported on.

Visually inspected with the use of binoculars where appropriate.



## Roofing including roof space

Pitched timber framed roof structure, clad with plywood sarking and profiled concrete roof tiles.

Concrete ridge tiles; cloaked verge tiles.

Fibreglass insulation to the ceiling joists.

Extended roof over the entrance door, supported by painted steel posts; leadwork flashings to the valleys.

Sloping roofs were visually inspected with the aid of binoculars where appropriate.

Head and shoulders inspection of the roof space only.

## **Rainwater fittings**

uPVC gutters and down pipes.

Visually inspected with the aid of binoculars where appropriate.

#### Main walls

The external walls consist of a structural timber frame, with block-work outer leaf.

The walls are dry-dashed externally.

Concrete window cills; smooth cement render below the DPC and to the ingoes.

Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.

# Windows, external doors and joinery

White uPVC framed double glazed windows and external door.

Timber fascia boards with composite board soffits to the front and rear elevations, and to the roof over the front door.

Internal and external doors were opened and closed where keys were available.

Random windows were opened and closed where possible. Doors and windows were not forced open.

#### **External decorations**

The timber fascia boards are painted.

Visually inspected.

## Conservatories / porches

There are no conservatories or porches.

Visually inspected.



#### **Communal areas**

There are no communal areas.

Circulation areas visually inspected.

## Garages and permanent outbuildings

There are no garages or permanent outbuildings. Timber garden shed.

Visually inspected.

## Outside areas and boundaries

Garden areas surround the house; these are mainly laid to grass.

Concrete paths around the house.

Stone walls and timber fences to the boundaries.

Visually inspected.

### **Ceilings**

The ceilings are lined with plasterboard.

Visually inspected from floor level.

#### Internal walls

Internal walls are timber framed and lined with plasterboard.

Visually inspected from floor level.

Using a moisture meter, walls were randomly tested for dampness where considered appropriate.

## Floors including sub floors

Solid concrete ground floor.

Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.

## Internal joinery and kitchen fittings

Fitted floor units to the Kitchen.

Flush sapele ply doors with fanlights above; half glazed door to the Vestibule; chrome lever handles.

Built-in wardrobes to the Bedrooms, with sliding louvred doors.

Softwood skirtings and facings.

White uPVC cills and ingoes.

Built-in cupboard to the Hall, containing the hot water cylinder; there is also a built-in cupboard in the Kitchen. Meter cupboard to the Entrance Vestibule.

Built-in cupboards were looked into but no stored items were moved.

Kitchen units were visually inspected excluding appliances.



## Chimney breasts and fireplaces

There is an open fire in the Sitting Room, consisting of a brick-built fireplace, tiled hearth and surround.

Visually inspected. No testing of the flues or fittings was carried out.

#### Internal decorations

Internal walls are emulsioned; ceilings are finished with textured plaster.

Interior woodwork is varnished.

Vinyl tiles to the back of the worktops in the Kitchen; ceramic tiles behind the sink.

Wall vinyl to the Shower Room.

Floor coverings consist of laminate and vinyl.

Visually inspected.

### **Cellars**

There are no cellars.

Visually inspected where there was safe and purpose-built access.

## **Electricity**

The property is served by a mains electricity supply to a distribution board and a smart meter in the cupboard in the Entrance Vestibule.

Stainless steel extractor hood to the Kitchen; ceiling mounted extractor hood to the Shower Room.

Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

## Gas

There is no mains gas in Orkney. No Calor Gas installation at the property.

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.



## Water, plumbing and bathroom fittings

There is understood to be a mains water supply to the property.

The pipework, where visible, is of copper and uPVC construction.

Sanitary ware includes:

Kitchen: single bowl stainless steel sink & drainer.

Shower Room: electric shower with a curtain above dished

area of floor, wash-hand basin, WC.

Insulated cold water header tank in the roof space.

Visual inspection of the accessible pipework, water tanks, cylinders and fittings without removing any insulation.

No tests whatsoever were carried out to the system or appliances.

## Heating and hot water

The property is heated by an electric storage/convector heater and a storage heater in the Sitting Room/Kitchen, electric panel heaters in the Bedrooms and an electric towel rail in the Shower Room.

Open fire in the Sitting Room.

There is a hot water cylinder in a cupboard off the Hall, which is fitted with 38mm thick spray-foam insulation and dual electric immersions.

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected.

No tests whatsoever were carried out to the system or appliances.

## Drainage

Drainage is assumed to connect to the mains drainage network.

Drainage covers etc were not lifted. Neither drains nor drainage systems were tested.

## Fire, smoke and burglar alarms

Smoke detector fitted to the Hall ceiling; high heat alarm to the ceiling of the Sitting Room/Kitchen.

Visually inspected.

No tests whatsoever were carried out to the system or appliances.



## Any additional limits to inspection:

At the time of our inspection the property was occupied and fully furnished with floors fully covered throughout.

Pitched roof coverings were inspected from ground level; a detailed inspection of condition was not undertaken.

An inspection for Japanese Knotweed or other invasive plant species was not carried out.


There was no access for inspection to the foundations or behind wall linings.

The drainage system was not open to inspection.

High levels of Radon gas have been recorded in areas of Orkney. No tests were carried out to detect the levels of gas in the property.





## The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. ## The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 24 kg CO<sub>2</sub>/m<sup>2</sup>/yr.

### PART 1 – GENERAL

#### 1.1 THE SURVEYORS

The Seller has engaged the Surveyors to provide the Single Survey Report. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited Energy Company.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Purchaser's lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors require to amend the valuation in consequence of such information, they will issue an amended Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon Residential Property. <sup>1</sup>

#### PART 2 – DESCRIPTION OF THE REPORT

#### 2.1 THE SERVICE

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by Statute and this is in the format of the accredited Energy Company.

## 2.2 THE INSPECTION

The Inspection is a general surface examination of those parts of the Property which are accessible: in other words, *visible and readily available for examination from ground and floor levels, without risk of causing damage to the Property or injury to the Surveyor.* 

All references to visual inspection refer to an inspection from within the property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the property.

The Inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

Unless identified in the report the Surveyor will assume that no harmful or hazardous materials have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

The Surveyor will not carry out an asbestos inspection, and will not be acting as an asbestos inspector in completing a Single Survey of properties that may fall within the Control of Asbestos in the Workplace Regulations. In the case of flats it will be assumed that there is a duty holder, as defined in the Regulations and that a Register of Asbestos and effective Management Plan is in place, which does not require any expenditure, or pose a significant risk to health. No enquiry of the duty holder will be made.

#### 2.3 THE REPORT

The Report will be prepared by the Surveyor who carried out the property inspection and will describe various aspects of the property as defined by the headings of the Single Survey report with the comments being general and unbiased. The report on the location, style and condition of the property, will be concise and will be restricted to matters that could have a material effect upon value and will omit items that, in the Surveyors opinion, are not significant. If certain minor matters are mentioned, it should not be interpreted that the property is free of any other minor defects.

**WARNING:** If left unattended, even for a relatively short period, Category 2 repairs can rapidly develop into more serious Category 3 repairs. The existence of Category 2 or Category 3 repairs may have an adverse effect on marketability, value and the sale price ultimately achieved for the property. This is particularly true during slow market conditions when the effect can be considerable. Parts of the property, which cannot be seen or accessed, will not be reported upon and this will be stated.
